Vendor Booth Rental Agreement

In order to sell ANYTHING INCLUDING PRE-ORDERS at the 2020 BSCA National Specialty you MUST be a Vendor and submit a signed Vendor Booth Rental Agreement

We are offering a limited number of indoor vendor spaces, 10×10 and 10×20 during our 2020 National Specialty Events to be held at the Crown Plaza Hotels & Resorts, in Asheville, NC.

Scentwork, agility, obedience, rally, and conformation will be held on site from Tuesday, April 14th through Saturday, April 18th, 2020. Set up will start on Tuesday, April 14th, and all vendor booths must be vacated no later than 5:00 PM on Saturday or the day the reservation ends. Vendors must supply their own set up. Payment must accompany reservations and is non-refundable after February 1, 2020.

In addition, we request a *\$50 item donation* be made to our general auction/raffle. Electricity is available for an additional cost and must be reserved early and directly through the Crown Plaza Hotels & Resorts. The show committee reserves the right to determine vendor location, but we will certainly try to meet all needs. Please note that no signs, banners, or decorations may be affixed to walls or doors of the conference center. When reserving your space, complete the information below. Be sure to sign all pages of the agreement where signature is required and mail 2 signed copies to the vendor chair, together with a check made out to:

INSURANCE: The vendor acknowledges that the Crown Plaza Hotels & Resorts and its owners, 2020 BSCA show committee, and Belgian Sheepdog Club of America, Inc. do not maintain insurance covering property brought onto the Crown Plaza Hotels & Resorts premises by vendors and that it is the sole responsibility of the vendor to obtain insurance covering such losses.

HOLD HARNESS CLAUSE: We submit the following "Hold Harmless Clause" which is part of the Crown Plaza Hotels & Resorts rules and regulations, to be incorporated in the contract vendors: "The vendor assumes the entire responsibility and liability for losses, damages and claims arising out of injury or damage to vendor's displays, equipment, and other property brought upon the premises of the Crown Plaza Hotels & Resorts and shall indemnify and hold harmless the Crown Plaza Hotels & Resorts agents, servants and employees from any and all such losses, damages and claims."

ACTS OF GOD: Neither party shall be responsible for any failure of performance due to Acts of God, labor disputes, shortage of commodities, or supplies to be furnished by the hotel, governmental authority, or accidents.

INDEMNIFICATION: To the extent permitted by law, you agree to protect, indemnify, defend and hold harmless the Crown Plaza Hotels & Resorts, and their respective officers, directors, employees and agents, the BSCA 2020 Show Committee and the Belgian Sheepdog Club of America, Inc. against all claims, losses or damages to persons or property, governmental charges or fines, and costs, (including reasonable attorney's fees), arising out of or connected with the BSCA Show Committee 2020 and the Belgian Sheepdog Club of America, Inc.

WAIVER OF JURY TRIAL: Each of the parties hereto knowingly, voluntarily and intentionally waives the right each may have to a jury in connection with any claim, defense, counterclaim, or other matter relating to this agreement.

ARBITRATION: The parties agree that any dispute in any way arising out of or relating to this contract may be resolved by arbitration to be conducted in Buncombe County, North Carolina. The parties further agree that in any arbitration proceeds they may conduct reasonable discovery pursuant to the Federal Rules of Civil Procedure, that North Carolina law will be the governing law, and any arbitration award will be enforceable in state or federal court.

ATTORNEY'S FEES: The parties agree that in the event that any dispute arises in any way relating to or arising out of this contract, the prevailing party in any arbitration or court proceeding will be entitled to recover an award of its reasonable attorney's fees and costs.

CONDITIONS OF ACCEPTANCE

GOVERNING LAW: This contract shall be governed by and construed under the laws of the State of North Carolina, if any provisions of the Contract are unenforceable under applicable law, the remaining provisions shall continue in full force and effect.

We are only offering space for the entire time of the 2020 National Specialty. We are not offering any reduced payment for any less time.
