## ENTRY INFORMATION

**Entry fees: \$85 TD  
\$125 VST**

(each including AKC recording/event service fees)

All entry fee checks or money orders (US funds) are to be made payable to CAPER. One check is sufficient for all enclosed entries.

Entries are to be mailed to: **BSCA/CAPER, 24902 Apple Rd, Waterford WI 53185.**

Entries must be received by **6 pm CDT Wednesday, March 18** after which time no entries may be accepted, cancelled, altered, or substituted. No telephone or verbal entries will be accepted. All changes and cancellations must be received in writing (email is acceptable) prior to closing, except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows published by the American Kennel Club.

All entries must be on official AKC entry forms. Entries will be returned if they are illegible, incomplete, are submitted with incorrect fees, or are photocopied without the reverse side instructions and agreement included. Checks returned for insufficient fees will have the entry cancelled; acceptance of such an entry will only be made if the full fees, plus a \$25 administrative fee, are paid via certified check or money order & received prior to the start of judging. Express & certified deliveries must include signature waiver permitting them to be left at the Secretary's address without receipt signature. **Entries received without signature release will be refused.**

Entries with email addresses will be acknowledged with an email receipt. Confirmations and judging schedules will be emailed after closing. If you want a hard copy confirmation mailed, please note this on your entry. CAPER is not responsible for non-delivery of emails due to delivery errors or spam blockers, **and no further efforts will be made.**

**Refunds:** Entry fees will not be refunded in the event of errors or cancellation of entries after the published closing date; in the event that a dog is absent, disqualified, excused by the veterinarian or judge, or barred from competition by the Event Committee; or in the event that extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the Event Committee make it impossible to open or complete the test.

**Fax/email entries:** Entries may be faxed to the Secretary at 206-222-2830, or emailed to secretary@caper-dogs.com. Both sides of each entry form must be included, completely filled out and signed, or the entry will not be accepted. Payment can be made via PayPal or credit card by going to www.caper-dogs.com/PayPalCCpayment.htm and following the instructions there. **Payment must include the \$2 per class additional charge to be valid.** Entries are complete when both entry form and payment are received.

**Entry errors:** Exhibitors are responsible for the correctness of entries. All entries which include an email address will be sent an entry verification email shortly after receipt. All errors will be corrected prior to closing; exhibitor errors discovered after closing cannot be corrected. Overpayments of less than \$5 per dog will not be refunded.

### Entry Information

- Entry is limited to AKC registered dogs 6 months of age or older.

#### Entry preference for TD entries:

Belgian Sheepdogs without a TD title  
Belgian Sheepdogs with a TD title  
All other breeds without a TD title  
All other breeds with a TD title

#### Entry preference for VST entries:

Belgian Sheepdogs without a VST title  
Belgian Sheepdogs with a VST title  
All other breeds without a VST title  
All other breeds with a VST title

- The TD test is limited to 3 entries. Entries for the TD test for dogs without a TD title must have included with the entry form a notice of certification from an AKC tracking judge stating the dog is ready for such a test.
- The VST test is limited to 4 entries. VST entrants must have a TD or TDU title.
- The draw for entries and alternates will be held at 7pm CDT on Wednesday, March 18 at the Test Secretary's address. All participants and alternates will be notified as soon as possible after the draw. Upon notification, alternates shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent on the day of the test, the first alternate entry present according to the order in which they were drawn shall fill the vacant position. Refunds will be made for any alternate who is does not participate in the draw for tracks, and for any absent/withdrawn entrant whose track is filled by an alternate.
- If the limit for entries is not reached in either the TD or VST test, a track, or tracks, may be substituted in the other according to Chapter 1, Section 15 of the Tracking Regulations.
- Bitches in season may participate provided that the Test Secretary and Judges are notified that a bitch in season is present prior to the drawing for tracks. The last track shall be reserved for the bitch in season. If there is more than one bitch in season, a second draw for these bitches will be held.

### Site Information

- TD test will be at Clyde Elementary School, 4182 Old Clyde Rd, Clyde NC 28721.  
The draw for TD running order will occur at 7:45am, with the first track to run shortly thereafter.
- VST test will be at Haywood Community College parking lot, 185 Freeland Dr, Clyde NC 28721.  
The draw for VST running order will occur at 9:45am, with the first track to run shortly thereafter.

### Awards

Each passing track will receive a medium rimmed pottery bowl with a BSD motif, beautifully done by Prairie Dog Pottery, and a green qualifying rosette.

### Directions to Clyde Elementary School

*From I-40 east or west:* Take Exit 37 to the south and turn left onto Wiggins Rd. Turn right onto US-19/23. In 5.7 mi, tun right onto Blackwell Dr. and quickly turn left onto Old Clyde Rd. Travel 2.8 mi and the school is on the left.

*From here to VST site:* Take old Clyde Rd/Broad St to Mulberry St and turn left. Turn right onto US19/23. Turn left onto Jones Cove Rd. Slight left onto Freeland Dr. College is on the left.

*From I-40 east or west:* Take Exit 27 south onto US-74. Take Exit 107 and turn left onto Jones Cove Rd. Slight left onto Freeland Dr. College is on the left.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/ Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
